





# WHY DOES THE ORDER HAVE INSURANCE?

The Order of the Knights of Columbus was founded at a time when there was no such thing as a "Social Safety Net". Families depended on each other for everything. If a man was seriously injured or died, his wife and children were usually destitute. The difficulty of life for widows and their children caused the formation of various orders of men such as the Moose and Elks. Some groups were basically drinking clubs while others subscribed to non Christian belief systems but all had a function of taking care of the helpless. It was in this climate that our founder, Father Michael J. McGivney, determined that there should be a group of Catholic men who would remain loyal to the Faith, who would defend the Church and who would also take care of the helpless. It is correct to tell others that the Knights of Columbus is a fraternal organization similar to the Moose or the Elks and that we are not officially affiliated with the Church. From its beginnings 127 years ago, the insurance program of the Knights of Columbus has grown and become one of the best programs in the world. While the Knights were providing insurance for members, other insurance programs and plans multiplied so that what was once a very special thing—Knights of Columbus Insurance—now looks like a lot of other plans. The biggest difference remaining is that the profit from our Knights of Columbus insurance goes to charitable causes while the profits from other insurance companies go to the company share holders. It's a very good program and worth a look.

## PLANNING YOUR RETIREMENT?

This month's column is for the baby boomers. Do you know what that is sneaking up on you? Retirement!

Ouch. I know. It's hard to believe isn't it? Seems like just yesterday...

But it's coming - and coming fast. And that's actually the good news.

Let me share with you some tidbits that may be of interest:

"The trend by companies to freeze or end their employee pension plans may have a big impact on baby boomers now on the cusp of retirement.

Boomers with pension plans have counted on monthly retirement checks at the end of their career, but increasing numbers of employers are ending their plans or halting future benefit accruals. Those at greatest risk include boomers in their late 40s and early 50s who are still at least a decade from retirement but too old to save enough to make up the difference in their pension benefits.

An August, 2005 survey by PricewaterhouseCoopers showed that nearly half of companies that expected to change their pension plans in the next year were considering freezing benefits for all employees. More than a third that offered pensions have already pared back these benefits over the last three years.

"This will definitely be a problem for baby boomers," says Karen Friedman at the Pension Rights Center. "You've been at a company under the plan and worked for years with that expectation, and then it's taken away."

# WHAT ARE THE FOUR DEGREES OF KNIGHTHOOD?

Our Council now has twelve First Degree Knights. It is therefore important to explain what the different degrees mean and how one can attain them.

In order to be a full member of the Knights of Columbus, a member must attain the Third Degree. The First Degree is the local initiation given at the local council level. The Second Degree is a District initiation while the Third Degree is conferred by the State. Many councils have local "First Degree Teams" but the Second and Third Degrees are usually conferred by large specially trained teams and the proceedings are therefore not frequent. The Second and Third degrees are usually taken at the same time—sometimes all three degrees are taken together. Each degree has a unique character and they culminate in formal Knighthood. Members who have not attained the Third Degree may not hold elective office in the Knights and all are encouraged to advance to the Third Degree expeditiously. There are no eligibility requirements other than current membership to advance to the Third Degree.

The Fourth Degree is the Patriotic Degree and it enrolls members in a different organization called an Assembly. Fourth Degree knights are not senior to Third Degree members. Membership in the Fourth Degree Assembly is voluntary and means membership in the official honor guard of the knights with a distinctive uniform that many think is the uniform of all of the knights, although it is not—there is no uniform for the members of a local council of third degree knights. Eligibility to become a Fourth Degree member consists of having been a Knight for one year and having attained the Third Degree. The advancement ceremony inducting men into the Fourth Degree is usually given once per year—ours is in February of each year.

## VOTE

The Council of Catholic Bishops has issued a voting guide that is available through the parish. All are encouraged to read the guide and to heed its lessons.

## THE 24-HOUR KNIGHT


Being a member of the Knights isn't as time-consuming as some prospects may think. When you ask prospects to join the Order explain that we are asking for 24 hours of their time each year in the following manner:

- 12 hours a year reading the weekly church bulletin, the state and local council newsletters and the monthly Supreme Council magazine COLUMBIA.
- 2 hours a year volunteering at a council event of their interest
- 2 hours a year attending two council prayer services with their family
- 2 hours a year on a council sponsored family project or event
- 2 hours a year attending one council meeting, if it is a good one they attend more
- 4 hours a year attending a council social function with their family

Once you've explained the time commitment to a prospect be sure that you have a Form #100 handy so that you can sign him up while you have his attention.
